Participation Rate: The Participation Rate is the percent of the gain (if any) in the Index Value that is used in the calculation of the Index Growth Rate. Index Growth Floor: The Index Growth Floor is the minimum rate of interest that will be applied to a particular index segment. Index Growth Floors for new index segments may change, but they will never be lower than the guaranteed minimum Index Growth Floor of 0.00% as stated in the policy. Once an index segment is created, its Index Growth Floor will not change.

Index Growth Cap: The Index Growth Cap is a factor used in determining index interest for certain indexed account segments. The current growth cap rate for an index segment is determined in advance. It may be raised or lowered before the segment is created, but it will not be lower than the guaranteed minimum Index Growth Cap as stated in the policy (3.00% for the S&P 500 Indexed Account). Once an index segment is created, its Index Growth Cap will not change.

Index Spread: The Index Spread is used in determining index interest for each Indexed Account segment in the S&P 500 Uncapped Indexed Account. The Index Spread may change over time, but will never be greater than the guaranteed maximum Index Spread of 30% as stated in the policy. Once an index segment is created, its Index Spread will not change.
