Index Growth Floor: The Index Growth Floor is the minimum rate of interest that will be applied to a particular index segment. Once a Segment is created, its Index Growth Floor will not change.

Index Growth Cap: The Index Growth Cap is the maximum rate of interest that can be credited on a particular Index Strategy Segment. The current growth cap rate for an Index Strategy Segment is determined in advance. It may be raised or lowered before the Index Strategy Segment is created, but it will not be lower than the guaranteed minimum stated in the Contract. Once a Segment is created, its Index Growth Cap will not change.

Buffer: The Buffer is the percentage of protected negative Index Return applied to amounts allocated to an Index Strategy Segment on the maturity date. Any negative Index Return in excess of the Buffer reduces the value of the Contract Fund. It may be raised or lowered before the Index Strategy Segment is created, but it will not be lower than the guaranteed minimum stated in the Contract. Once a Segment is created, its Buffer will not change.

Step Rate: The Step Rate is the minimum rate of interest that can be credited on a particular Index Strategy Segment when the Index return is zero or positive. It may be raised or lowered before the Index Strategy Segment is created, but it will not be lower than the guaranteed minimum stated in the Contract. Once a Segment is created, its Step Rate will not change.

Spread: The Spread is a percentage that reduces the value of positive Index Returns used in determining index interest for each Indexed Account segment in the S&P 500 Enhanced Cap Rate Indexed Strategy. The Index Spread may change over time, but will never be greater than the guaranteed maximum Index Spread stated in the Contract. Once an index segment is created, its Index Spread will not change.
