If the index return is positive, then the interest rate credited is point-to-point to the index return rate until it is capped at the 10.5% cap. When the index return is negative, no interest will be credit to the account.

If the index return is positive, then the interest rate credited is 6 month point-to-point to the index return rate until it is capped at the 4.75% cap. When the index return is negative, no interest will be credited to the account.
