## Fund Performance Summary

The table above shows the historical performance of the Variable Investment Options invested in shares of the Funds offered by The Prudential Insurance Company of America ("Prudential") through the PruBenefit Select group flexible premium variable universal life insurance contract (the "Group Contract").

"Inception date" is the date the Fund was first made available to Contract Holders. The Group Contract was first offered on June 30, 2006. As of June 30, 2011, Prudential no longer offers these contracts for sale.

The "Cumulative Total Return" for each Fund is the difference between the end of period share value and the beginning of period share value, divided by the beginning of period share value, expressed as a percentage. Returns of less than one year are not annualized.
