Actions of state and federal legislators have a tremendous impact on how Prudential operates as a public company and competes in its financial services markets. Accordingly, it is important that the company have the opportunity to maintain an active role in the public policy arena and express its views to legislators who have a strong interest in issues of importance to the company, our shareholders, and our employees.

Federal law and certain state laws prohibit corporations from making political contributions but permit company sponsorship of two political action committees (PACs) that are in operation at this time.

The Prudential PAC and the Prudential New York PAC are voluntary, bipartisan programs established to encourage employee participation in the political process and to make contributions on their behalf to state and federal candidates and committees. Their contributions are approved by the PAC Board, comprised of Prudential employees, and go directly to support these candidates and political committees. The Prudential PAC and the Prudential New York PAC disclose their contributions in reports filed with the Federal Election Commission and the New York State Board of Elections.

In 2007, the Prudential PAC raised \$355,000 from eligible employees. The attached political contributions report details amounts contributed, including limited corporate contributions, and provides a federal and state level summary.

Prudential is an active participant in the political process of government through the Prudential PAC and through corporate contributions, as permitted by applicable election laws and corporate policy. Prudential's external affairs representatives are engaged in a wide range of issues including retirement security, corporate taxation, privacy, and regulatory reform.
